This law determines, in principle, whether a man or woman has the legal capacity to marry and how the inheritance of a deceased person should be shared. If a married person is domiciled in England, the English courts are competent to dissolve or cancel the marriage. If a married person is domiciled, for example, in France, then a divorce decree issued by the French courtscomparisons or to such a person will be recognized in England. Apart from the conflict of laws, the domicile also has a meaning in other areas of law, especially in the tax one. Tax a person's domicile must be established by applying English law and not by the rules of a foreign legal system.The general meaning of domicile is "permanent home". This seems fairly clear, but the view expressed by Lord Cranworth V-C in Whicker v. Hume (1858) that a person's domicile is what he considers his permanent residence is too simplistic and, indeed, somewhat misleading. It is true that for most people their domicile coincides with their permanent residence. However, domicile is a legal concept and a person's "basic" domicile is his or her original domicile, which is attributed to him or her by law at birth, and is not necessarily the country where his or her family resides permanently at that time. The terms "Home" and "Residence" are often confused as the same. However, the two legal definitions are different. "Home" is your "permanent home", while "Residence" is your "temporary home". The difference between the two lies in how long you plan to live in a specific place. However, both are important in determining your taxes, benefits, and other obligations. The law of domicile is of great importance in countries where the maxim "actor sequitur forum rei" is fully applied.More Domiciles A man cannot be without a domicile, because he should not have abandoned his last domicile until he has bought a new one. Although by Roman law a man could leave his home, and until he bought a new one, he was homeless. By fixing his residence in two different places, a man can have two homes at the same time, for example, if a foreigner, coming to this country, established two homes, one in New York and one in New Orleans, and spent half the year there, he would, in most cases, have two homes. However, it should be noted that the circumstances considered sufficient to establish a commercial domicile in wartime and a matrimonial, forensic or political domicile in peacetime may not be such as to establish a principal or testamentary domicile, as there is a great difference in the application of the law of domicile to contracts and wills. Types of Domicils There are three types of Domicils: 1. The domicile of origin. 2. The domicile by operation of law, or domicile necessary. 3. Domicile of choice. Domicil by Origin Domicil dâorigine refers to the home of a manâs parents, not the place where a child happens to be born when the parents are visiting or travelling. The domicile of origin must be distinguished from the place of accidental birth. Domicile by law There are two classes of people who acquire domicile by law. Those who are under the control of another, and to whom the law grants the domicile of another. These include: 1. The 2. The minor. 3. The madman, etc. 2d. Those to whom the State assigns a domicile. Among this class there are: 1. The officer. 2. The prisoner, etc. Among those who, being under the control of another, acquire the domicile of such a person, I am the wife. A party may have two domiciles, one real, the other legal; the husband is actual and the wife domicile, they are, first facie, one. The domicile of that person may be modified by the management, or by the consent of the guardian, expressed or implied. The law gives a home. 1. Public offices, such as the President of the United States, secretaries and other officers whose public duties require a temporary residence in the capital, maintain their domiciles. The ambassadors retain the domiciles they have in their respective countries, and this privilege extends to the ambassador's family. The officers, soldiers and seamen, at the service of the United States, do not lose their domiciles while so they employ. 2. A prisoner does not acquire a domicile where the prison is, nor loses his old man. The domicile of origin, which has already been explained, remains until another has been acquired. In order to change this domicile, there must be an effective removal with the intention to reside in the place where the party removes. A simple intention to remove, unless such intention is brought into effect, is not enough. When he changes, he acquires a domicile in the place of his new residence and loses his original domicile. But after a return with the intention to reside, its original domicile is restored. restored.
