While there is a uniform law on marriage and divorce adopted by some states, details and procedures vary still wildly. Some states have also adopted the Uniform Divorce Recognition Act, requires that divorce be deposited in the state where both spouses live. If they get a divorce in another state, their state of residence will not recognize it, causing big problems along the way if one of them wants to remarry. States which have not adopted the Uniform Divorce Recognition Act have a residency requirement for divorces, which means you must have lived in that state for a specified length of time before you can file for divorce there. Since some states also have requirements for long separations before divorces can be final, people looking for quick divorces often move temporarily to states that have shorter separation periods just to get their divorces faster. So, how are you getting a divorce? Do you have to go to court? If you have a contested divorce or are looking for a bad divorce in order to get more spouse support or child custody, then the answer is probably yes. Otherwise, then going to court is not always necessary. In fact, currently only about 10% of divorces are taken before a judge. Most of them are settled by the court. Binding Divorce Typical divorce involves a spouse filing a claim and then both spouses hiring lawyers. Each attorney begins "discovery" to determine how to divide marital property. Eventually, either the two attorneys work a settlement on behalf of their clients or it goes to court and is decided by a judge. The couple is not actively involved in the negotiation. The final settlement covers the distribution of property, child and groom support and child custody/visiting issues. Mediated DivorceMediation is growing in popularity for divorce because it puts the couple responsible for negotiating and how the property is distributed. With the help of a neutral professional, the couple can discuss and negotiate issues to achieve a result that both parties are comfortable with. If mediation doesn't work, they can go ahead with the traditional case, litigation and let a judge decide. The couple does not completely avoid court with mediation. The agreement has yet to be approved, the forms completed and the divorce is finalized through a court process. But, they avoid having their dirty laundry in public and don't have to call friends and family to testify at a trial. Collaborative-law DivorceAnother option that is growing in popularity and availability is collaborative law. The collaborative law is a new dispute resolution process that includes a written and direct agreement stating that the divorce will not go to court. Instead, it is more of a dispute resolution approach where the couple remains in control through face-to-face trading sessions. These sessions include both spouses and their lawyers. They can also hire professionals such as therapists, assessors or other counsellors. Basically, the lawyers are there to answer legal questions, and the couple controls the negotiations. Both spouses have agreed that the information will be exchanged (discovered) in a timely manner. For every spouse their individual interests and needs better than anyone else, this process allows them to present those needs and find a solution quickly. Rather than being out to "win" -- creating an adversarial atmosphere -- lawyers in this case become become become Solvers and negotiators because the whole focus and objective of the process is settlement.
